THROUGH NO FAULT OF THEIR OWN, MANY HORSES END UP IN DIFFICULT CIRCUMSTANCES, AND ARE VERY CLOSE TO BEING IN AN INESCAPABLE AND HOPELESS SITUATION. SADLY, THEY SOMETIMES END UP BEING NEGLECTED OR SOLD TO SLAUGHTER.
